- a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- b. No child shall be subjected to physical punishment or mental harassment.
- No child is required to pass any board examination till the completion of elementary education.
- Inclusion of students with disabilities/special need as per provision of the RTE Act 2009 of J&K (rule/clause of the state Act).
- The teachers are recruited with minimum qualifications as laid under UT recruitment rule (rule/clause of the state Act).
- The teachers perform his duties specified under RTE Act 2009 and RTE Act 2009 and SRO 123 of J&K (rule/clause of the state Act).
- The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- The school shall maintain the standards and norms as specified in SRO 123 of J&K (rule/clause of State Act).
- No unrecognized classes shall run within the premises of the school or outside in the name of the school.
